GENERAL NOTES:

1. PROVIDE 1/2" EXP. JT. MATERIAL W/ SEALANT WHERE NEW CONC. CURBS, WALKS, OR PAVING ABUT STORM SEWERS STRUCTURES, BUILDINGS, ETC.
2. AT END OF PROJECT, CONTRACTOR SHALL REMOVE ALL TEMPORARY FENCING, TEMPORARY EROSION CONTROL STRUCTURES, AND OTHER TEMPORARY SERVICES ON SITE.
3. ALL RADI ARE TO BE 5' UNLESS SHOWN OTHERWISE.
4. CONSTRUCTION SHALL BE IN ACCORDANCE WITH ALL LOCAL, STATE, FEDERAL GOVERNING AGENCIES.

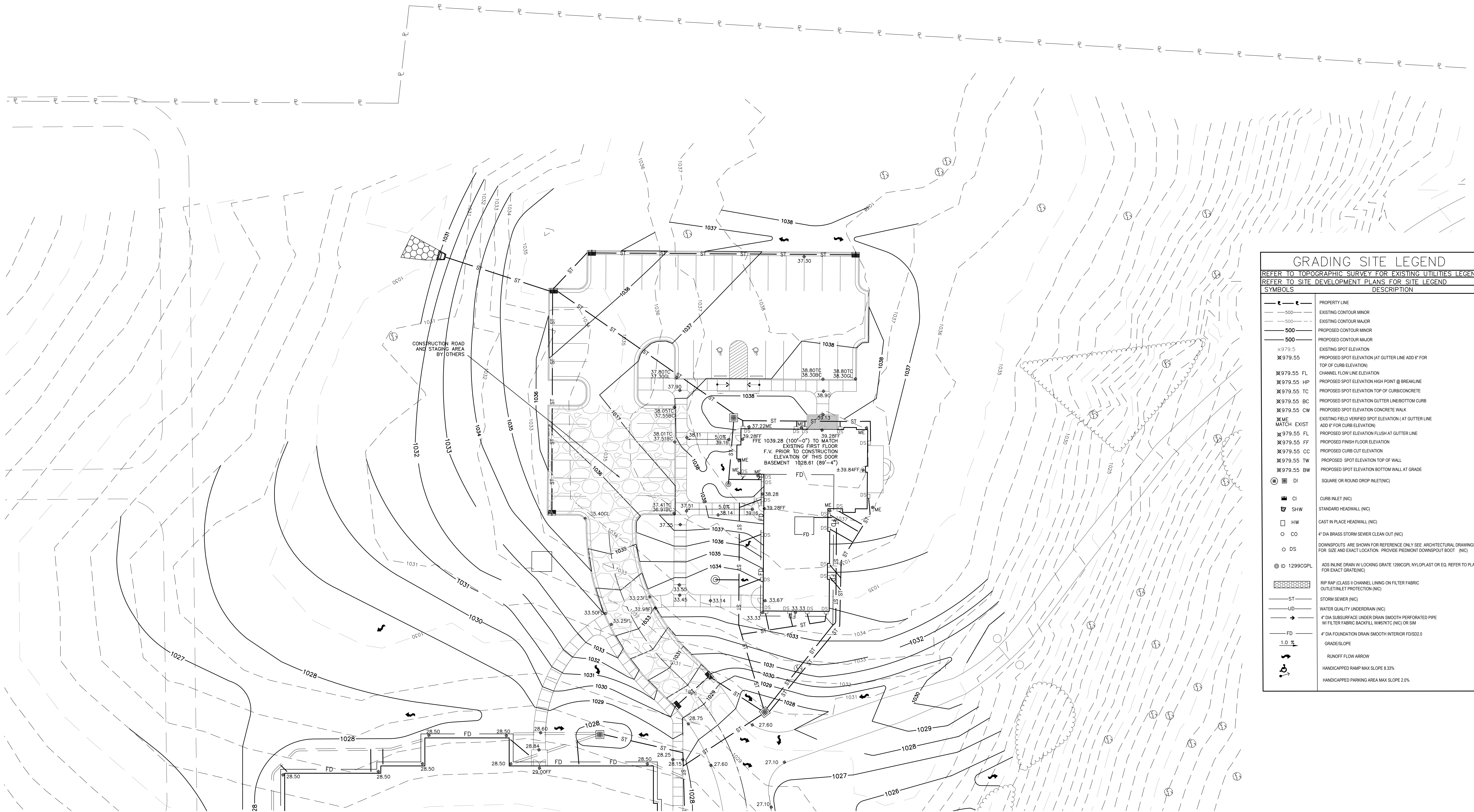

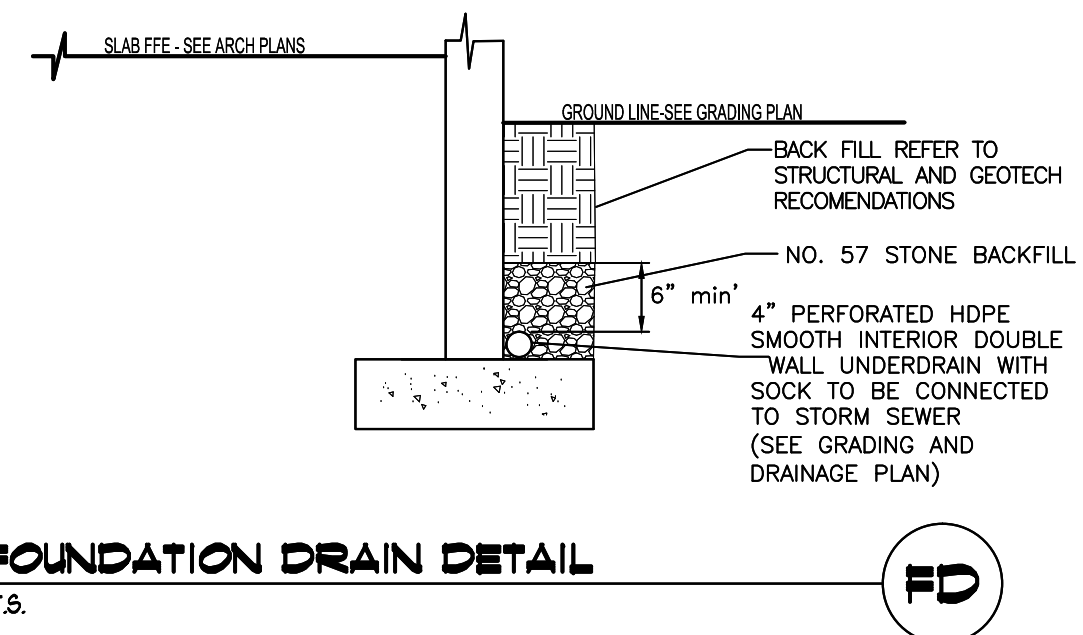

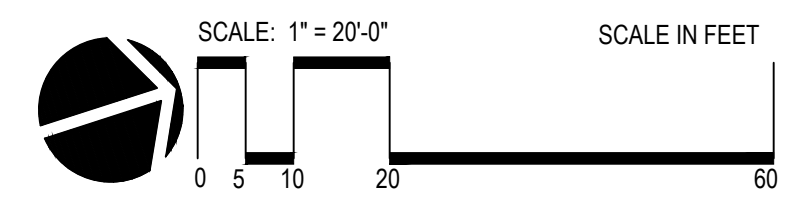

INSTALLATION OF FOUNDATION DRAINS WITHIN 5FT OF BUILDING FOOTPRINT AND COORDINATION OF EARTHWORK AROUND BUILDING WITH SITE CONTRACTOR.
WASTE SOIL MATERIAL EXCAVATED FROM BASEMENT ON SITE IN AREA AND MANNER DIRECTED BY THE SITE CONTRACTOR RESPONSIBLE FOR FINAL GRADING.
